## HIBBEN UNITED METHODIST CHURCH COVENANT STATEMENT

Hibben United Methodist Church is committed to providing a safe and secure environment for all children, youth, vulnerable adults, and volunteers who participate in ministries and activities sponsored by the church. The following policy statements reflect our congregation's commitment to preserving this church as a holy place of safety and protection for all who would enter and as a place in which all people can experience the love of God through relationships with others.

- 1. No adults who have been convicted of child abuse (either sexual abuse, physical abuse, or emotional abuse) should volunteer or apply to work with children or youth in any church-sponsored activity.
- 2. Adult survivors of child abuse need the love and support of our congregation. Any adult survivor who desires to volunteer in some capacity to work with children or youth are encouraged to discuss his/her willingness with one our church's ministers before accepting assignment.
- 3. Adult volunteers will not be allowed to be an adult leader in any children/youth ministry unless they have been a member of the church for 6 months. However, the volunteer can act in an assistant role before 6 months of membership.
- 4. Adult volunteers or employees that work with children and youth shall observe the "Two-Adult Rule" These adults should be non-related. If the the Two-Adult Rule is not feasible a roaming approved adult with an unobstructive line of view must be present.
- 5. Volunteers and Employees that work directly with children and youth will receive training on the Sanctuary policy of Hibben United Methodist church.
- 6. All volunteers and employees that work with children shall immediately report to their supervisor any behavior that seems abusive or inappropriate.
